In 2014, a suit was commenced in the British Virgin Islands ("BVI") by Lin Chee Keen and Steven Ng (together the "Claimants") against Dr David Lee and 5 companies within the Ferrell group of companies. The BVI suit relates to investments made by the Claimants with Ferrell Asset Management Limited ("FAML").

On or about 13 October 2014, the BVI High Court dismissed the Claimants' application for service of their claim out of jurisdiction against Dr David Lee, which then effectively brings the BVI proceedings to a halt. No further action has been taken thereafter in the BVI proceedings against Dr David Lee.

In addition, the BVI High Court subsequently struck out the Claimants' claims against 2 other companies.
